14 **Comes now before you Commercial Salmon Fisherman, members,**
15 **active and in good standing, of the Yurok Tribe. We hereby seek relief,**
16 **by form of Petition, via the following financial compensation as**
17 **allocated by the U.S Congress, H.R. 1591, Title III, Chapter 1.**

19 **The following methods of allocation and disbursement is endorsed,**
20 **supported and hereby authorized to be conducted in the following**
21 **manner:**

22 **Eligibility:** shall be defined as any member of the Yurok Tribe that
23 **qualified, via Tribal training video, AND possessed a Commercial**
24 **Salmon Harvesting Buoy in the 2004 Commercial Season.**

1 **Adult Commercial Salmon Tribal Members shall have the option of**
2 **choosing one of the following:**

3 **A flat rate direct cash disbursement in the amount of \$3,500.00**

4 **Or**

5 **A variable rate of \$17.50 per fish, as verified and documented by**
6 **Official Yurok Commercial Fish Tax Records, using the best seasonal**
7 **catch from the previous 2001, 2003, or 2004 Commercial Season.**

8
9 **Commercial Salmon Tribal Members 14 to 17 years old shall have the**
10 **option of choosing one of the following:**

11 **A clothing voucher in the amount of \$2,000.00 Or Having the money**
12 **placed in an interest bearing Trust Account until they reach the age of**
13 **18 Or A variable rate of \$17.50 per fish, as verified and documented**
14 **by Official Yurok Commercial Fish Tax Records, using the best seasonal**
15 **catch from the previous 2001, 2003, or 2004 Commercial Season. The**
16 **amount to be disburse in a clothing Voucher or placed into an interest**
17 **bearing Trust Account until they reach the age of 18.**

19 **Commercial Salmon Tribal Members 13 years or younger shall have**
20 **the option of choosing one of the following:**

21 **A clothing voucher in the amount of \$1,500.00 Or Having the**
22 **money placed in an interest bearing Trust Account until they reach the**
23 **age of 18.**
